## Section 5. Fire-fighting measures

### Personal precautions, protective equipment and emergency procedures

### Methods and materials for containment and cleaning up

- Spill** : Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material

## Section 7. Handling and storage

### Precautions for safe handling

- Protective measures** : Put on appropriate personal protective equipment (see Section 8).
- Advice on general occupational hygiene** : Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. - Conditions for safe storage, including any incompatibilities** : Store in accordance with local regulations. 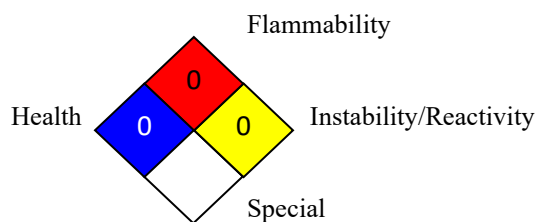
